# Redcar Proposed as Pioneering Hydrogen Community



We are delighted that Ofgem and BEIS have given us the go ahead to develop our plans to bring hydrogen for heating and cooking to some areas of Redcar, creating the UKs first hydrogen village.

The proposal involves switching the gas supply from natural gas to clean burning hydrogen for around 2,000 homes and businesses in parts of Redcar including the town centre, Warrenby, Coatham and an area of Kirkleatham from 2025, with a decision about whether the project will progress made in 2023.

The plans involve producing hydrogen in Teesside, meaning Redcar would be self-sufficient, generating its own hydrogen locally, from renewable sources.

To achieve the target of net zero carbon emissions by 2050, the government and industry are exploring the option of repurposing the UK's gas network to transport 100% hydrogen. Today around 700 homes near Gateshead are already being heated by a blend of hydrogen and natural gas and some homes in Fife, Scotland will become the first to use 100% hydrogen. If ultimately approved, the project is expected to begin from 2025 and run for around two years.

Our Redcar based project team will now spending time with local businesses and residents over the coming months, to help develop our proposals and design our project in more detail.

NGN is expanding its apprenticeships programme, recruiting seven full time roles across our Business Admin Support functions including Communications, Operational Training, HR, Finance and Connections.

The two-year course will see apprentices graduate with a Business Administration Level 3 qualification and will join 27 Craftsperson and Operative apprentices, who all successfully passed their first-year milestone this month having joined NGN during the pandemic in 2021.

Speaking of her first year as a Network Maintenance (E&I) Apprentice, Freya Osment, 26, comments: "I've really enjoyed my first 12 months. I really appreciate working with such a great team and having so many years of knowledge passed on to me. I have surprised myself at how I have picked things up and retained so much information in such little time."

With NGN leading the sector in research and development of green energy technology, including hydrogen's use for domestic heating, apprenticeships offer a way to equip the next generation of our people with the skills to support a transition to a low-carbon energy future.

The apprentices of 2022 will play a crucial role in helping our workforce be ready for net zero.
