Hydrogen Village Trial Update



Earlier this month, we learned that the Government has decided not to pursue Cadent's bid to host the first hydrogen village in Whitby, Ellesmere Port.

Redcar Hydrogen Community now remains the only possible location for the hydrogen village, which is a government initiative to supply around 2,000 homes and businesses with 100% hydrogen instead of natural gas for heating and cooking, for up to two years from 2025.

Cadent's proposal faced significant challenges from to a sustained community campaign, which ultimately led the Government to conclude that there was not enough public support to proceed.

Our plan has generated a small amount of local opposition, but we are confident the support of Redcar residents remains strong, thanks to building solid links with the community and the dedicated efforts of our Redcar-based customer team. We also continue to have the full backing of local council leaders and Redcar MP Jacob Young, who tweeted on Monday evening that our proposal has his 'full support', and that he believes the hydrogen village trial is vital and that Whitby residents were influenced by 'a campaign of mistruths'.

While this latest news is undoubtedly a positive step for our proposal, we have not yet been awarded the village trial yet.

Our bid was submitted at the end of March and since then discussions have been ongoing with the Department for Energy Security & Net Zero (DESNZ). We expect a final decision later this year

# Keeping young people and their families safe.



Lucy R, aged six, from Wakefield and Betty F aged nine from Hexham, have won the regional prizes for the annual schools' carbon monoxide (CO) safety competition.

Organised by the UK's four gas distribution networks and supported by the Energy Networks Association, the competition calls for creative young people aged five to eleven to use their creative skills to help raise awareness of the dangers of CO.

We received some fantastic entries in this year's competition from school children, and clubs and organisations for young people. Entries ranged from videos, presentations, posters, cartoons, and poems, all designed to warn of the dangers of the deadly gas, known as the 'silent killer' as it can't be seen, smelled, heard or tasted.

As NGN's regional winners, Betty and Lucy won £150 for themselves and £300 for their schools.

Lucy's fantastic video then went on to win the KS1 national round, securing £450 for herself and £900 for her school.
