Creating an 'eco house' for Redcar and Cleveland College



Northern Gas Networks (NGN) is partnering with Redcar and Cleveland College to showcase what hydrogen in homes in place of natural gas could really look like.

The college's Sir William Turner Eco House, which is the old caretakers lodge at Redcar and Cleveland College, will be heated by a hydrogen boiler and retrofitted with a hydrogen hob, oven, and fire, which will allow visitors, students, and the community to get a first-hand look into tomorrow's world.

The transformation of the Eco House is the latest step in preparation for the Redcar Hydrogen Community Project, which, if approved by government, will see NGN supply greener energy, instead of natural gas, to approximately 2,000 homes and businesses in parts of Redcar including Coatham, Warrenby and an area of Kirkleatham. A decision about whether the investment is awarded to Redcar is expected later this year, with the conversion of the gas network to 100% hydrogen expected to take place in 2025. The project will operate for around two years.

As well as providing Redcar residents with a place to see hydrogen operating in a home setting, the house will provide the college with training opportunities, for those looking to specialise in green skills needed for the future.

Situated in the proposed catchment area, if the pilot goes ahead, the college will become the first in the UK to use 100% hydrogen.

The Eco House is expected to open later this summer.

Energy network companies and leading charities join forces to support older people.



We have launched a new partnership with Age UK to support older people who are in, or at risk of, fuel poverty.

The collaboration, which includes Age UK, Age Scotland, and Age Cymru, as well as Cadent, Wales & West Utilities and SGN is a £1million partnership focused on helping older people gain access to the benefits and monetary support they're entitled to, potentially increasing their household income by up to £2,000 a year on average.

The campaign will help ensure that older people in the UK can access support services which help increase household income,

including benefits checks. It will also provide information on how to use energy safely and efficiently at home.

The funding, which has been provided through the Vulnerability and Carbon Monoxide Allowance (VCMA) by the energy industry regulator Ofgem, also allows the charities to sign elderly customers up to the Priority Services Register – ensuring they'll receive extra support if they're ever without their gas, water, or electricity supply.
